Student Achievement

Mitchell Community College continuously reviews data pertaining to all aspects of student achievement in areas which are aligned with its mission and the population it serves. These data include student success in collegiate English and Math coursework; first year progression; transfer success at a four-year University of North Carolina (UNC) System institution; and licensure exam pass rates. Mitchell evaluates these data using both internal processes as well as performance measures, required and reported by the North Carolina Community College System (NCCCS), as part of its institutional effectiveness efforts. These system-wide measures are reported annually in the Performance Measures for Student Success report. Each of the NCCCS performance measures has a related performance goal, determined by the North Carolina Community College System Office, based on previous performance of all 58 NC Community Colleges. The College understands the importance of student achievement and uses the results of the performance measures as part of institutional improvement efforts.
